I Henry J. Butler of Warren County Kentucky being of sound mind and disposing memory and knowing the undertaking of human life do make and publish this my last will and testament. Item 1st It is my will and I direct that as soon after my death as convenient all my just debts be paid. Item 2nd It is further my will and I give my beloved wife Rebecca O Butler the tract of land upon which I now live containing one hundred and ten acres more or less and also a small tract of timbered land being the same that I purchased from James A. Scrivener containing about 28 acres for and during her natural life remainder to my grandchildren William Henry Butler, Mary Ida Butler and Daniel Robert Butler children of my son John Thomas Butler, and if either of them should die without issue then the portion of that one so dying to go to and be equally divided between the survivors. Item 3rd It is further my will and I give to my beloved wife Rebecca O. all my personal property of every description including horses, mules, cattle, hogs all my notes and accounts, and after the death of my said wife if any of said personal property is not used by her and any of same remains at her death then my will and desire is and I do so direct that it shall be divided equally between my said grandchildren William Henry Butler, Mary Ida Butler and Daniel Robert Butler children of my son John Thomas Butler. The reason that I do not give my children anything in this will is because I have heretofore given them as much of my property as I desire for them to have. Item 4th I hereby appoint John E. Walsell of Bowling Green Ky, the Executor of this my last will and testament. In testimony of which I herein to set my hand this 3rd day of October 1877.

HISTORY OF HICKORY, POLK, CEDAR, DADE AND BARTON COUNTIES, MISSOURI, 1889. published by Goodspeed, 1889; Pgs. 776, 777

Dr. John D. Simrell, practicing physician and surgeon of Washington Township, was born in Sullivan County, Ind., in 1835, and is the third of two sons and three daughters born to William and Mary (Whalen) Simrell, natives of Tennessee. They were reared in that State, were married there, and ther remained until 1830, when they removed to Indiana. Mr. Simrell died there in 1870, and Mrs. Simrell in 1882. Both were members of the Methodist Church for many years, and the father was a farmer by occupation. He was the son of William Simrell. The maternal grandfather, John Whalen, was born in North Carolina, and died in Indiana. He was a soldier in the War of 1812, with Jackson. Dr. John D. Simrell began for himself at the age of fifteen as a farm hand, and attended school when he had the means. In 1856 he began the study of medicine, but soon discontinued that and took up the study of law, which, after continuing for some time, he abandoned and returned to the study of medicine, having previously taught a year. In 1859 and 1860 he attended the Eclectic Medical Collage at Cincinnati, Ohio, then taught school, and continued his studies until 1864, when he joined Company D, First Indiana Heavy Artillery, and served in Louisiana until the close of the war. He was private secretary of Gen. William P. Benton, at first, but afterward assisted in the medical department. He was married, in 1857, to Miss Albarado, daughter of James and Jemima Hughes. Mrs. Simrell was born in Kentucky, and died in 1866. She was the mother of three children, one daughter now living. Mr. Simrell's second marriage was in 1869, to Miss Sudie, a native of Morgan County, Mo., and the daughter of Andrew and Nancy Masters, natives of Kentucky and Tennessee, respectively. Mr. and Mrs. Masters came to Cedar County, Mo., before the war, and here Mr. Masters died in 1870. Mrs. Masters is still living. Mr. Masters served in the militia during the war, and was probate judge several terms in Morgan County. To the Doctor and last wife were born seven children, three sons and four daughters. He first came to Cedar County in 1866, and has since lived in Washington Township, where he has 640 acres in several farms, all the result of his own work. He has practiced his profession with considerable success ever since locating in Cedar County, and is one of its leading physicians as well as farmers and stock-raisers. He has been a Democrat in his political views all his life, and his first presidential vote was for James Buchanan in 1856. He has been a member of Humansville Lodge of the I. O. O. F. for about seven years, and has held various offices.

Jacob Butler, the son of William Butler, Sr., did not settle within the 500-acre Survey, but he is important to Oliver Springs history because many of his descendants were, and are, residents of the Oliver Springs community. By 1805, Jacob had settled in East Fork Valley near the present Anderson-Roane line and across Black Oak Ridge from his father and brothers on Min Poplar Creek. He purchased land from James Sandifer (C, p 25), Jacob Keith (C, p105), and Charles McCllung (J, p 34). Jacob's name appears many times in Anderson County Court minutes as overseer for roads and for jury duty.

Jacob M. Butler was a large man with black hair and grey eyes. He prospered as a farmer. He divided his farms in Hardin Valley among his children to provide each of them with a farm. He then bought a 400-acre farm, known as "The Bend Farm," in the bend of Clinch River at the present site of the Clinch River Breeder Reactor. Jacob M. served as a JP in Roane County. After he married his second wife, a widow, he moved to her farm in the Ten Mile Community of Meigs County. Jacob Butler bought The Bend Farm from Matthew Davis in 1833 (Book J., p 464). His heirs sold the Bend Farm to Christopher Columbus Smith in 1858 (Book N., p 157). William Butler, Sr. was born 1738, and died 9 November 1836 in Anderson County TN. He married ANN DUCKETT.

The Butler families' story began in Anderson County when Charles McClung conveyed to Thomas Butler one thousand acres of land on Poplar Creek located on both sides of the present Oliver Springs - Oak Ridge highway. Deed recorded in Knox Co. Deed Book F, Vol, 2, page 8, dated 13 Feb 1800. Shortly after 1800, Thomas Butler sold a part of this original tract to his father, WILLIAM BUTLER, SR., a RWS, and parts to his brothers, WILLIAM BUTLER, JR. and HENRY BUTLER, and parts to his sisters, ELIZABETH MANLEY and MARY RECTOR. His brother, JACOB BUTLER, bought a tract located in East Fork Valley near the Anderson - Roane line.

William Butler, Sr. bought 422 acres of land from his son, THOMAS BUTLER, in 1807 (Anderson D, page 37). Among the many early Butler deeds recorded in Anderson County, TN, for conveyances of land sales and of slaves, are these examples:

G, page 134: William Butler, Sr. to his granddaughter, JANE RECTOR, my Negro boy named JIM, 10-25-1828

G, page 155: William Butler, Sr. to my grandson, WILLIAM G. BUTLER, 100 acres on Poplar Creek adjoining William Butler and ANCIL MANLEY, 2-13-1828

I, page 16: William Butler, Sr. to William R. Butler, Henry R. Butler, and John W. Butler (grandsons), 70 acres on Poplar Creek beginning on Thomas Butler line, 1832

I, page 131: William Butler, Sr. to Rhoda Butler, wife of my grandson, William R. Butler, my Negro woman named BETSY, 1834. He was a Revolutionary War Soldier from Bedford County, VA. Submitted an affidavit dated 1 April 1834 in Anderson County, TN for pension. In the affidavit, he swore that he was 96 years of age, and that he volunteered for service under Capt. Samuel McCampbell on the last of May 1780 and returned home in September of 1780. He served this four month tour of duty against the Indians in the western part of VA at McDonald's Fort on Greenbriar River where his company of 66 men had a small battle with the Indians. He received a discharge from his Captain, but said discharge was lost.

William Butler, Sr. again entered service in February of 1781 as a volunteer under Capt. Thomas Helems and marched into NC where his company, under Gen. Greene, took part in the Battle at Guilford, March 15, 1781, in which battle his captain was killed. Private Butler returned to his home in May of 1781.

At the end of the affidavit, his aged hand tried to affix the signature, but only the first part is legible, and the Justice of the Peace, ROBERT GALBRAITH, signed for him and William made his mark.

The above affidavit was accompanied by an affidavit made and signed by RICHARD OLIVER and ALEXANDER GALBRAITH. The early Butlers did not appear to be active in politics, yet it is interesting to note not only the quality of the penmanship of the signers, but the fact that each of the signers was a former High Sheriff of Anderson County.

His will is recorded in Anderson County Will Book, 1830-1840, page 141. An abstract follows:

To my son, THOMAS, my Negro girls, ELIZABETH and NELLY.

To my daughter, Elizabeth Manley, my Negro women, JANE, BARBARY, CLOE, and FAN, and Negro boy, MOSES  
To my son, HENRY, and to my son, WILLIAM, my Negro man JOSEPH, and girl, MARGARET.  
To my daughter, MARY RECTOR, my Negro woman, JUDE, and her child, SETHANY  
To my granddaughter, ELIZABETH PRYOR, my Negro girl, MARIE.  
To my grandsons, JACOB and BENJAMIN RECTOR, \$50 in money each.  
To my granddaughter, NANCY RECTOR, my Negro boy, JAMES.  
WITN: JAMES CRACE, JANE B. RECTOR Recorded Jan 16, 1836

William Sr. does not name his son, JACOB, in his will, and he does not give the first name of the husband of his daughter, MARY, who married a RECTOR. By other records, Jacob is known to be a son, and Elizabeth to be the wife of ANCIL MANLEY. It is not known whether the granddaughter, ELIZABETH PRYOR, was the child of a daughter who had married a PRYOR, or whether Elizabeth, the granddaughter, had married a Pryor. Evidently, William Butler, Sr. had brought many slaves with him from Virginia.

1. THOMAS2 BUTLER , SR (WILLIAM1) was born 11 November 1763 in Frederick Co. MD, and died 1834. He married CHARLOTTE RECTOR.

Although William Butler, Sr. RWS, was the revered patriarch of the Butler clan, it was his son, THOMAS A. BUTLER, SR., also a RWS, who paved the way for the families to move from VA to Poplar Creek in present Anderson County. Thomas A. Butler was the initiator and the leader in the family. On February 13, 1800, he bought from Charles McClung 1000 acres from the 5000-acre tract on Main Poplar Creek and parts of Brush Fork and Mountain Fork of Poplar Creek (Knox F, Vol. 2, pg. 8). He sold parts of his 1000 tract to his father, brothers and sisters who soon followed.

On April 4, 1834, Thomas Butler, Sr. made an affidavit in a RW pension application in Anderson County in which he stated that he was born Nov 11, 1763 in Frederick County, MD, and that his parents moved when he was young to Bedford County, VA, in that portion which was cut off later to form Campbell County, VA. He enlisted as a private horseman during the fall of 1780, and saw limited action at New London, Petersburg, and Portsmouth. He was verbally discharged after this tour of three months. Thomas A. again volunteered and marched with the army by old Jamestown to Williamsburg and on to the siege of Yorktown. The applicant was under the command of Col. Skipper the night that the British "spiked four of our canons." In his statement,

Thomas A. says that he was standing beside a man by the name of VAUGHN when said Vaughn's head was shot off. He did much labor in throwing up batteries during the siege, and when the British magazine was blown up, he saw the bodies of many British soldiers flying up into the air. After the surrender of British Gen. Cornwallis, he was unable to serve as a guard of the prisoners, and was given a written discharge by Dr. Cogswell which certificate has long since been lost. This abstract contains the high points of the affidavit.

SAMUEL GALBRAITH and CHARLES Y. OLIVER submitted affidavits to the County Court to support the pension application. Four months after the above application, Thomas died (8/31/1834) and is probably buried in an unmarked grave near the Butler Cemetery.

Thomas A. erected a saw- and a grist-mill, and a large iron forge at the confluence of Brushy and Mountain Forks of Poplar Creek. MATTHEW RHEA states that by 1830, iron produced from this forge and one other on Brushy Fork was the third leading product in Anderson County. Although details are not known, the iron works was in operation over a considerable period of time and evidently required the employment of a large number of people for all phases of its operation. Under a TN law passed in 1824 for the encouragement of iron works, Thomas A. received a grant (no. 16591) for 2600 acres on the condition that the iron works would be kept in repair and in operation. The 2600 acre tract was located to the NE of the forge and between the property lines of the GALBRAITHS and the HOSKINS lines across Pine Ridge. This tract was still a part of the Thomas A. Butler estate after his death, and was included in the division of his estate by a Court-appointed Commission.

In addition to the 3600 acres mentioned, Thomas A. continued to obtain more land by State grants and by purchase, including various mill sites and coal and other mineral lands in Morgan County. He entered the seven-acre tract, later known as the Salt-Well Tract, and a one-acre "coal bank" in 1808 which is probably the earliest written reference to coal in TN records. Thomas was also the promoter of the Butler Turnpike in Morgan County in 1817, which was to connect Piles Turnpike with the Cumberland Road. Thus, it may be seen he was a big land and slave holder, and a large-scale entrepreneur of proven ability.

Thomas A. Butler, Sr. died in testate and no precise, or official list of his children has been found. Fortunately, in Anderson County Deed Book J., page 131, JOHN W. BUTLER, a son of Thomas A., sold his one-ninth interest in his father's estate to the remaining legatees and devisees who are named in part. Thomas A. Butler's children appear to be as follows:
